


MINUTES OF PRE BID MEETING HELD ON 17th JUNE 2016

A pre bid meeting for supply of laboratory material for residential school has been conducted on 17th June 2016 at 3.00pm. Total 04 intended bidders were present in the meeting. The points raised by the bidders in the meeting and clarifications given by the **Commissionerate Social Welfare, Maharashtra State, Pune** are as under:

Organizations but also supplies of same industry products to reputed organizations should be allowed. 2) The time schedule of this tender which required 70 samples to be submitted is too short & also not as per Government resolution dated 30/10/2015. Please see Para 4.4.3 on page no. 58 & amend the tender schedule as per that. 3) No condition restricting this tender to only manufacturers is found nor any format for dealership is given, but 5crs experience is asked, that makes this tender non conclusive. Pl clarify who can participate whether trader or Manufacturer? 4) The eligibility for manufacturers & there authorized dealers should be drawn separately.	Experience not restricted in tender Document for similar items. Date Extension is given. Being 70 items no necessity to give any specific separate eligibility for manufactures as items are procured from various sources.

3	Lotus Commercials 202, 2nd floor, Sharda chamber, New Marine Lines, Charchgate, Mumbai-20	We would like to bring your kind attention to the point No. I of PROCEDURE FOR UPLOADING OF BIDS at page No. 15, where in it mentioned that copy of CA Certificate of Bidder indicating turnover of their company minimum Rs. 5000 lakhs in last three years. However, if you go through the page no. 3 of bid documents, NOTICE INVITING BIDS the EMD asked for is Rs. 427,000/- only. It appears that irrational proportion to the ratio of Turnover and EMD in terms of value. We, therefore request you to kindly clarify this matter and oblige.	Typing error.
