Pre-bid meeting conducted on 24.03.2017 for Empanelment of UPSC Coaching Institute at any city in Six Revenue divisions in Maharashtra State and the points discussed in the meeting are as under

1	Sambodhi Academy, Parbhani	In the technical evaluation criteria in the bid document out of 100, 20 points are given for previous result of the institute and 20 points are for quality of study material and regularity and quality of test series. It is taking into consideration test series implemented in the previous year's also. The bidders are raising question that out total 100 marks 40 marks are depending on previous experience of the institute and the qualification criteria for technical evaluation is 60%. So the institutes which are not having previous experience are not able to qualify the technical evaluation criteria. In light of this, the minimum qualifying marks may be reduced so that the institutes which do not have any previous experience of UPSC teaching will be eligible to apply.	BARTI wants to empanel renowned & prestigious coaching institutes having good track record for this coaching program. Keeping in mind these criteria's final decision about selection of coaching Institutes will be taken by BARTI.
2	Spectram Academy	The bidders are requesting that BARTI shall give minimum numbers of students who will be sponsored by BARTI for this coaching program so that the fixed amount of fees will be assured by BARTI.	Depending upon preference of coaching Institute by the Students final decision will be taken by BARTI. Institutes may get minimum nil students and maximum 30 students.
3	Crusedser the gardian Academy, Amravati	If the students are opting various optional subjects and the institute is not having competent staff for various optional subjects then BARTI shall give liberty to exclude the coaching of that particular optional subject.	Depending upon choice of optional subject by the students final decision will be taken by BARTI.
4	Crusedser the gardian Academy, Amravati	The set of booklets and study material may not be upload in hard copy format so the bidders requested to accept the notes in hard copy format to BARTI. Also they requested to accept the hand-written notes.
