We _____ (Name of the Bank), hereby expressly, irrevocably, and unreservedly undertake and guarantee as principal obligators on behalf of the seller that in the event that the beneficiary submits a written demand to us stating that the seller has nor performed according to the terms and conditions of the Tender, we will pay you on demand and without demur any sum up to a maximum amount of (1% of the Tender value). Any claims must bear the confirmation of your bankers that the signatures thereon are authentic. Your written demand shall be conclusive evidence to us that such written demand. For the avoidance of doubt any documents received by way of facsimile or similar electronic means is / are not acceptable for any purpose (s) under this guarantee.

1. We shall not discharged or released from this undertaking and guarantee by any arrangements, variations made between beneficiary and that seller or any forbearance whether as to payment, time performance or otherwise.
2. In no case shall the amount of the guarantee be increased.
3. Unless a demand under this guarantee is received by us in writing on or before the expiry date (unless this guarantee is extended by the seller), all your rights under this guarantee shall be forfeited and we shall be discharged from the liabilities hereunder:

4. This guarantee shall be a continuing guarantee (which means guarantee will also be valid if the bank is in under liquidation or bankruptcy) and shall not be discharged by any changes in the constitution of the bank or in the constitution of the seller.
5. Please return this letter of guarantee immediately after our liability thereafter has ceased to be valid.
6. Our liability under this guarantee will cease to be valid even if the guarantee deed is not returned to us.
7. This guarantee is personal to the beneficiary and not assignable to a third party without our prior written consent.
