But now if bidder has either of one it shall be considered.

3) There was lot of confusion on documents required to be submitted by

Manufacturer or bidders on behalf of manufacturers changes are made as per

4) There was requirement of bending & press brake machine now to be read  
As either of one machine should be there with the manufacturer.

5) Maharashtra state small scale industries development corporation ltd  
Claimed For exemption from paying the earnest money deposit & have  
Submitted the relevant government letter from industry department within the  
Time limit given by the committee chairman. It was decided that the  
exemption can not be granted.

6) There was problem being faced by certain bidders to download the tender  
Form & wanted the department to intervene, but were informed that ample of

What we want in Gatai tender is that bidding company must fulfill following requirements, If manufacturers

- 1) buy 50,000 tender form
- 2) pay 25 lacs EMD
- 3) pay 1.5 lacs testing fees
- 4) have 50 crs turnover OR have 25 crs solvency
- 5) all machineries as per Annexure " E "
- 6) ISO certificate

Bidders having tie up with Manufacturers in that case Bidder must meet following requirements

- 1) buy 50,000 tender form
- 2) pay 25 lacs EMD
- 3) pay 1.5 lacs testing fees
- 4) have 50 crs turnover OR have 25 crs solvency
- 5) Authorization letter as per annexure " D "

And such bidders, Manufacturers should have

- 1) all machineries as per Annexure " E "
- 2) ISO certificate

## 7.0 SUBMISSION OF BIDS

Bids must be submitted online strictly as per e tendering schedule.

### (a) Technical Bid -

The technical bid must contain the following documents:

- (i) Attested copy of Bid Security payment receipt ***paid by the bidder***
- (ii) Attested copy of Bid Form fees
- (iii) Tender document down ***loaded by bidder*** duly signed should be submitted.
- (iv) Attested copy of Testing Charges paid Receipt and Form of Undertaking for payment of additional testing charges as per annexure " F " ***by the bidder***
- (v) Attested copy of ***bidder*** Solvency Certificate of Rs.25Cr issued not later than 6 months from the due date of tender.
- (vi) Attested copy of VAT Registration Certificate.
- (vi) Attested copy of CST Registration Certificate.
- (vii) Attested copy of shops and Establishment License.
- (viii) Attested copy of partnership deed/Memorandum/Articles of Association as the case may be.
- (ix) Attested copy of VAT Clearance certificate up to 31-12-2010
- (viii) Attested copy of Permanent Account Number (PAN) card allotted by Income Tax Department, Government of India, in the name of firm/proprietor/agency for Income Tax payment.
- (ix) Attested copy of Sample Submission Challan
- (x) Attested copy of manufacturers valid ISO Certificate.
- (xi) Attested copy of ***bidder*** TurnoverCertificate / Annual Report / Audited Balance Sheet.
- (xii) Undertaking from Manufacturer on Rs 100/- stamp paper duly notarized by notary with red seal on it as per annexure " E "
- (xiii) Manufacturer's Authorization Letter as per annexure " D "
- (xiv) The bidder must submit attested copy of Power of Attorney of the person of the firm signing the bid documents and other documents of the tender

## QUALIFICATION REQUIREMENTS

- 1 M.S. Fabricators who have all the relevant facilities of fabrication or their authorized dealers must quote. The authorized dealers must submit their offers along with letter of authority from such M.S fabricators as per the accompanying Proforma on letter head in original from M.S.Fabricator.
2. The **bidder** must have average, annual turnover of Rs. 50 Crores and above during last 3 years in fabrication business only. Audited Balance Sheet/CA Certificate or Annual Report must be submitted.
3. The M.S. Fabricator must mandatory confirm possessing the in-house requirements which shall be submitted as undertaking as per accompanying proforma on Rs 100/- stamp paper which must also be notarized along with red seal. The authorized signatory of the M.S. Fabricator must submit his Power of Attorney along with the concerned Board Resolution for the Power of Attorney.
4. The M.S. Fabricator unit should submit copy of valid ISO certificate.
